1		The boundary wall of the school at some places (near the main gate) is still less than 06 ft height with concrete boundary wall which is made with 04 ft concrete boundary wall with iron mess fixed at the top. School is directed to raise the height

	of concrete boundary wall for safety an security of the students and staff and upload the compliance with video link on SARAS portal within 03 months.
2	School has not made proper seating arrangements in the library and the classroom desks are arranged for seating facilities which are not suitable and recommended as per Board guidelines and SoPs vide circular no 11/2022. School is directed to follow the SoPs for library and upgrade the seating arrangements with proper tables and chair and stock as per the guidelines and upload the compliance on SARAS portal within 03 months.
3	Standard safety measures should be adequately arranged in the composite science lab as per Board guidelines and SoPs notified vide circular no 11/2022. Plastic stools and for seating arrangement are not safe due to heating facility and concentrated chemicals and non availability of exhaust fans is also seen in the lab. School is directed to upgrade the lab with all recommended facilities and infrastructure as per guidelines and upload the compliance with video on SARAS portal within 03 months.
4	School has not provided the salary statement being made to the staff as per the Govt norms through proper bank transfer for last three months but has only shown the online salary with EPF made to the staff members. School is directed to make the salary to the staff as per state govt salary slabs and upload the each month salary statement at MPD on school website mandatory with EPF statement and also upload the compliance on SARAS portal with last three months salary statement with each staff details.
5	School building is G+2 upper floors but the CWSN toilets are not available separately for boys and girls at each floors. The entrance of the toilets is small and narrow where the ramps made at the entrance of CWSN toilets are also not safe and made as per the guidelines with proper gradient and side support railings. School is directed to follow the Board guidelines and circular no 05/2023 and the statutory provisions of the RPwd Act and make the arrangements for CwSN facilities at each floors as per guidelines and upload the compliance on SARAS portal within 03 months.
6	The lift to access the upper floors is still under construction as noted from the RC videography where school has assured to complete the work very soon. School is directed to make the lift functional and upload the compliance with video link on SARAS portal within 03 months.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The above sanction is subject to fulfillment of following conditions:-

- 1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
- 2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school is required to renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- 7. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- 8. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

"The school shall possess valid fire safety certificate and Building safety certificate during functioning of the school which shall be renewed from time to time as per norms".

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
